



	 <ol style="list-style-type: none"> Undo the cable clamp screw. Lift up the cover of the clamp, be careful not to displace the EMC gasket which is located on the cover. Insert the conductor into the terminal slot which is located in the casing of the module. Before closing the cover check to ensure that conductor, screening braid and cable are in the correct position as shown below. Carefully close the cover of the module ensuring that the EMC gasket is not displaced or damaged.
