



	 <ol style="list-style-type: none"> <li>1. Undo the cable clamp screw.</li> <li>2. Lift up the cover of the clamp, be careful not to displace the EMC gasket which is located on the cover.</li> <li>3. Insert the conductor into the terminal slot which is located in the casing of the module.</li> <li>4. Before closing the cover check to ensure that conductor, screening braid and cable are in the correct position as shown below.</li> <li>5. Carefully close the cover of the module ensuring that the EMC gasket is not displaced or damaged.
